Mary, Kathy, Cyndi, Karole, Donna, Jan. (meeting will be Sunday Dec. 13 @ 3 pm at Barbara's) Jan – interest in **Driving Orienteering? Mounted** Orienteering club is willing to set up an event to include drivers. Several

members interested. Amanda - Premise liability needs to be checked on for summer events; homeowners' insurance may not cover competitions. Amanda – suggested we have potluck / free driving day. The Treasure Valley Whips hold several play days each year. **These events are** open to anyone who is interested in learning more about driving, from beginners without horses to experienced drivers. The February 27<sup>th</sup> & March 27<sup>th</sup> play days will be held at the Birt Arena facility in Nampa, Idaho (see directions at bottom of the next page). There are several areas that can be used at the facility, depending upon the weather. We typically include a "bomb-proofing" area with lots of flags, plastic, tires, etc. to get our horses accustomed to, usually while leading them through the area. This makes the play day an excellent place to bring a green or young horse for some experience. The indoor arena is available for 20 minute individual sessions and we will also have some group sessions for those wanting to get experience with others in the ring. We also set up some driving courses (e.g. cones, hazards, & dressage) for participants to learn and to practice. Our participants include folks who are leading their horses, ground driving them, driving hitched to a vehicle, riding their horses as well as those who are just coming to get more information. The club also sets up an information table with all sorts of articles, magazines, pamphlets, catalogs and other educational information about driving.

The schedule is kept fairly unstructured, so that the participants can set their own pace, but occasional demonstrations and lessons are offered as well. As our club grows, more and more members are available for putting on demonstrations and giving lessons at these play days depending upon participant interest.

The play days are open to the public, but membership is rewarded with a discount.

## Cost is \$10 per member bringing up to 2 horses each; \$15 for a non-member bringing a horse (\$15 per horse).

These fees are used to defray the costs of the facility rental, insurance, equipment, etc. Members get a discount, because they invest in the club to fund the overhead expenses. If you are not a member, look into joining. The club needs members to cover annual expenses, and you will ultimately benefit financially!

<u>Divisions/levels</u>: Training and Preliminary; <u>Classes</u>: horse (over 14.2 hh), pony (12 hh - 14.2) small pony/VSE (under 12 hh); singles and pairs/multiples in each class.

Entry Fee (member rate/non member rate): Training & Preliminary: \$35; Extra Dressage tests (next level up) \$15; Non-member fee: \$15

<u>Dressage Information</u>: ADS Training Level #2, Preliminary Level #1. Two minute warm-up allowed in arena immediately before the test.

<u>Hazards</u>: Two marathon type hazards will be set up. Exhibitor will pass through start/finish gate of hazard #1, drive through the lettered gates of the hazard in order, A, B, & C, (and D if Preliminary) and come out start/finish gate. The exhibitor will be signaled when the timer is ready for them to drive the second hazard. This process is repeated until the Exhibitor has driven the hazards #1, #2, #1, and #2. No cantering in Training level.

<u>Cones Information</u>: **Training**, minimum of 40 cm clearance; **Preliminary**, min. 35 cm clearance. Scores will be based upon penalties for time over the allowed time and/or course penalties (balls down). Possible multiple ("L" "double L" or serpentine).

<u>Tentative Schedule:</u> Office opens 8:30; <u>Dressage</u> drive times begin at 9:00 (<u>assigned times will be available the day before the competition</u>); <u>Hazards</u> immediately after Dressage; <u>Cones at 1:30</u>; awards after completion of cones, approximately 3:00.

She currently owns Equine Basics, an educational endeavor to provide solutions to horse throughout the Midwestern region. She is a successful competitor and drives and competes with singles through four-in-hands and is currently long listed for the USET Driving team for the World Pony Championship. She is very approachable, fun and a wonderful teacher.

#### **CLINIC AND ADT FORMAT:**

- Individual lessons, in a public format Questions and discussion after each lesson.
- Group ADT course walks with Ms. Marks before each competition. (Dressage, Hazards & Obstacles - Cones)
- ADT will be held over both days. (Dressage on Sat.; Hazards and Obstacles-Cones on Sun.)

**TENTATIVE SCHEDULE: SATURDAY: AM:** Lessons; **PM:** Lessons and Dressage test walk and competition, ending by 6:00: **SUNDAY: AM:** lessons and Hazard course walk and competition; **PM**: Obstacle -Cones course walk and competition, lessons and ADT awards.

Exhibitor will pass through start/finish gate of hazard #1, drive through the lettered gates of the hazard in order, A, B, & C, (and D if Preliminary) and come out start/finish gate. The exhibitor will be signaled when the timer is ready for them to drive the second hazard. This process is repeated until the Exhibitor has driven the hazards #1, #2, #1, and #2. No cantering in Training level.

<u>Cones Information</u>: Training, minimum of 40 cm clearance; <u>Preliminary</u>, min. 35 cm clearance. Scores will be based upon penalties for time over the allowed time and/or course penalties (balls down). Possible multiple ("L" "double L" or serpentine).

Awards: Ribbons 1-4 in each class; also best dressage, cones, hazards; best in level.
