TACTICS OF DRIVING DRESSAGE:

or

***WHY AM I BEHIND THIS HORSE
STILL LEARNING DRESSAGE***

ALL THINGS CONSIDERED:

Driving your horse should be.....well.....Fun. A get-away in the great outdoors for clearing of the mind. Quality time with that wonderful individual: Your Horse. Quality time with a wonderful friend or family member working and learning as a team. Or as in my case: My retirement teaching job and still.....Fun. That decision made, with whip and lines in hand and feet planted on the ground you are told... In order to be really successful and SAFE you and your horse must learn:

Dressage:

In former times, friendly partnership between man and horse was of vital importance, whether for transportation, for the dissemination of culture or for warfare. Nowadays (and for the foreseeable future), the horse is used primarily as an instrument of sport, show, or for rambling at ease in the country. There are many Drivers/Riders

who, when they buy a horse, take his goodwill for granted. The art of training a horse to obey his driver cheerfully and willingly is the fruit of centuries of research, and is in danger of being lost forever, notwithstanding the fact that Our safety and the Safety of our Equine Partner/s is of utmost importance. This training is called Dressage.

With this in mind, beginning our year of driving, may I review for us all, (I being the person who needs it the most), a few training stages we need to have firmly planted in the horse's memory.

Does the horse stand tied quietly?

Does the horse walk quietly when being led, stop when you stop, and back a few steps when asked in hand?

Is your horse trained on the single and /or double longe line and responsive to your voice commands?

Do you use Vienna Reins and work no longer than 5 to 10 minutes in each direction on the longe?

Do you understand the importance of Work in Hand and Long Reining for the suppling and collection of your horse?

Has your horse been ridden or still being ridden for training? Pleasure?

Has your horse been ground driven extensively (without and with blinkers/blinders, winkers etc.) by you, his favorite person, so he is familiar with your voice, and hands?

And if your horse is already been "Harnessed up" and "Put To" does he move forward with energy and willingness?

Does he balance well in the turns and travel straight on the straight lines and on the curves? (This oxymoron we will talk about).

These few logical beginning steps to driving your horse in balance and harmony, are tactics you will continually refresh in your mind and that of your

horse in order to keep that wonderful partner sound and happy well into his older years. Quiet Obedience, Forward in Rhythm, Suppleness, and above all straight, will be the things we can help you with and look for at our Club Play day and ADT in February at the Birt Arena in Nampa. Come and join us for Lots ofFUN!

MEMBERSHIP DRIVE 2006

In its first year (2005), the club sponsored seven play days, three arena driving trials, a carriage pleasure driving show, two cross country drives, a clinic and barbeque, and an endurance drive. We publish a newsletter, in which we report on club events and notify members of upcoming events. We plan on continuing these types of activities for 2006. The Treasure Valley Whips hold several play days each year. These events are open to anyone who is interested in learning more about driving, from beginners to experienced drivers. Many of them are held at the Birt Arena facility in Nampa, Idaho. There are several areas that can be used at the facility, depending upon the weather. We typically include a “bomb-proofing” area with lots of flags, plastic, tires, etc. to get our horses accustomed to, usually while leading them through the area. This makes the play day an excellent place to bring a green or young horse for some experience. We also set up some driving courses (e.g. cones, hazards, & dressage) for participants to learn and to practice. Our participants include folks who are leading their horses, ground driving them, driving hitched to a vehicle, as well as those who are just coming to get more information or catch a ride. The club also sets up an information table with all sorts of articles, magazines, pamphlets, catalogs and other educational information about driving.

The schedule is kept fairly unstructured, so that the participants can set their own pace, but occasional demonstrations and lessons are offered as well. As our club grows, more and more members are available for putting on demonstrations and giving lessons at these play days depending upon participant interest.

This year, we will hold a few of our play days the same weekend as a driving show or arena driving trial (Feb. and March so far). Hopefully, the play day will give participants a chance to practice on Saturday before the show or trial on Sunday in the winter months. The Birt’s also now have completed their stable that includes 18 wonderful stalls. This will enable folks who want to come from out of the area with their horses to participate, as well as those of us who would like to overnight our horses for the show or trial the next day. The stalls will be available for rent. There are electrical hook-ups for RV’s available as well. Contact the show/trial organizer for more information.

The play days are open to the public, but membership is rewarded with a discount. Cost is \$10 per member bringing a horse(s); \$15 for a non-member bringing a horse(s); Play days are free to members coming without horses and \$5 for non-members coming without horses. These fees are used to defray the costs of the facility rental, insurance, equipment, etc. Members get a discount, because they invest in the club to fund the overhead expenses. If you are not a member, look into joining. The club needs members to cover annual expenses, and you will ultimately benefit financially!
